COMMUTATION OF SENTENCE

Louis Calderon

In January 1999, 19-year-old Louis Calderon was driving with several other gang members. Mr. Calderon pulled up next to a car occupied by Christy Alvarez, and one of his friends pulled out a gun and shot at Ms. Alvarez, hitting her in her left eye. She survived, but lost her eye as a result. On April 5, 2000, Mr. Calderon was sentenced by the Los Angeles County Superior Court to 7 years to life for attempted murder plus a firearm enhancement of 25 years to life, a total prison term of 32 years to life.


Mr. Calderon has applied for executive clemency, stating, "I have taken the opportunity over the years of my incarceration to better myself and prepare myself to re-enter society as a productive citizen." Indeed, in his nearly 18 years of incarceration, he dropped out of his former gang and, in spite of the pressures in prison, has never been disciplined for a single rule violation. Mr. Calderon has worked to improve his education, earning multiple community college degrees and a paralegal certificate. He has routinely received above average and exceptional work ratings and has put thousands of hours into his work with the Prison Industry Authority. Mr. Calderon has actively participated in numerous self-help programs. A Correctional Counselor reported that Mr. Calderon was known to be very respectful and hardworking, and two teachers commended him for his efforts to assist struggling students. He has served on an education committee, donated to charities, spoken at a graduation ceremony, tutored inmates working to obtain their GEDs, and mentored at-risk youth.

This is a very serious crime, but it is clear that Mr. Calderon has distinguished himself by his exemplary conduct in prison and his forthright and continuing separation from gang activities of any kind. For all of the foregoing reasons, I conclude that it is appropriate to mitigate his sentence.

THEREFORE, I, EDMUND G. BROWN JR., Governor of the State of California, by virtue of the power and authority vested in me by the Constitution and statutes of the State of California, do hereby commute the sentence of Louis Calderon to a total of 22 years to life.
